### **TERMS AND CONDITIONS**

Information on how to enter and prizes form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.

Entry into the promotion is open to all residents of Australia excluding retail tenants at Royal Randwick shopping centre and their immediate family, and staff of retail tenants in the participating shopping centres and their immediate family, the proprietors and staff of companies involved in the production, publishing and administration of this promotion and their immediate family.
