

Shop, Spin and Win \$10k Promotion Terms and Conditions

ELIGIBILITY

5. This Promotion is only open to individuals who are aged 18 years or over, and who are residents of New South Wales, Victoria, Queensland and Western Australia (in Australia), or of New Zealand.
6. The following individuals are ineligible to enter the Promotion:
 - a. employees, directors, officers and management of the Promoter, any related bodies corporate of the Promoter, or any of the tenants or retailers in the participating Centre, or any of the Promoter's agencies that are associated with the Promotion;
 - b. the spouse, de facto spouse, parent, child or sibling of an individual listed in paragraph a.; and
 - c. any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

PROMOTION PERIOD

7. This Promotion:
 - a. commences at 12.01am AEST on 17/08/2026 and ends at 11.59pm AEST on 30/08/2026 (for Australian entrants); and
 - b. commences at 2.01am NZST on 17/08/2026 and ends at 1.59am NZST on 31/08/2026 (for New Zealand entrants)

(each, a “**Promotion Period**”).

8. For the avoidance of doubt, differences in start and end dates are due to time zone differences between Australia and New Zealand.

HOW TO ENTER

9. To enter this Promotion, eligible individuals must, during the Promotion Period:
 - a. spend a minimum of \$20 in one transaction from any retailer in a Centre (excluding online) and collect your itemised purchase receipt (**Qualifying Purchase**);
 - b. visit the Website (for the Centre where you have made your Qualifying Purchase);
 - c. locate the entry page and fill out and submit the online entry form, including by uploading an image of the Qualifying Purchase receipt and providing all other requested information to receive 1 entry into the major prize draw; and
 - d. once your receipt has been validated, you will then receive an email from the Promoter inviting you to “Spin to Win”, where you must follow the instructions in the email to “spin” and see if you have won an instant win prize for the Centre where you have entered.

For clarity, you must complete steps 9 (a – c) during the Promotion Period, however if you choose to “spin” to see if you have won an instant win prize (per step 9 (d)), you must complete this by **11.59pm AEST on 01/09/2026** (for Australian entrants) and **1.59am NZST on 02/09/2026** (for New Zealand entrants).

10. The Promoter is not responsible if your mobile device/desktop is not sufficiently capable for the purpose of submitting an entry, including having the requisite photograph capability.
11. Receipts from the purchase of alcohol, tobacco, lottery tickets or gift cards are not accepted as part of this Promotion.

PROOF OF PURCHASE

12. You must keep your original itemised purchase receipt(s) as proof of purchase for all entries. If you don't produce the proof of purchase for all entries when asked, the Promoter may disqualify those entries and you will lose any right to a prize.
13. The receipt must be identical to that provided by you with your entry.
14. If, in the Promoter's reasonable opinion based on the available information, you have shared any purchase receipts with another person, your entries will be invalid, and you will lose any right to a prize.

17. To avoid doubt, there is a limit of one entry per Qualifying Purchase receipt. For example, if you spend \$40 in a single Qualifying Purchase transaction, that receipt can only be used to enter once.

INSTANT WIN PRIZES

18. There are up to 8,140 instant win prizes available to be awarded randomly (instant win prizes vary per Centre) during the Promotion Period by a computerised random system at Komo Technologies Pty Ltd, 152 St Georges Terrace, Perth, WA, 6000.
19. Once you have successfully entered the major prize draw, and after your receipt has been validated, you will receive an email inviting you to "Spin to Win". MAJOR PRIZE DETERMINATION

22. The major prize draw will take place at 12pm AEST on 04/09/2026 (which is 2pm NZST) at Gadens Lawyers, L13 447 Collins Street, Melbourne VIC 3000. The Promoter may draw reserve entries and record them in order in case of an invalid entry/entrant, or the major prize is unclaimed (**Major Prize Reserve Entrants**).
23. The first entry selected randomly from the valid Australian and New Zealand entries received during the Promotion Period will win the major prize.

WINNER NOTIFICATION

25. The provisional major prize winner will be notified by phone or email within 7 days of determination. GENERAL

44. 45. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
46. If this Promotion is interfered with or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention, tampering with the entry process (including manipulating the system via bots, script use, or any other means to circumvent the entry process) or fraud, the Promoter reserves the right to the fullest extent permitted by law to (a) disqualify an entrant engaging in unauthorised intervention or fraud; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.
47. If any dispute arises concerning the conduct of this Promotion, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. However, the Promoter's decision is final, and no correspondence will be entered into.

53. The Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including without limitation:
- a. any technical difficulties or equipment malfunction;
 - b. any theft, unauthorised access or third party interference;
 - c. any entry or correspondence that is late, lost, altered, damaged or misdirected due to any reason beyond the reasonable control of the Promoter;

 - e. any tax liability incurred by an entrant or winner; or

55.
