TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is Royal Randwick Shopping Centre, 73 Belmore Road, Randwick, NSW, 2031 (ABN 13 001 595 955) telephone **02 9398 9099** ("**Promoter**").
3. Entry is only open to Australian residents aged 18 years or over.
4.
