

ROYAL RANDWICK EASTER EGG HUNT PROMOTION
TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is AMP Capital Shopping Centres Pty Limited, Royal Randwick Shopping Centre, 73 Belmore Road, Randwick, NSW, 2031 (ABN 13 001 595 955) telephone +61 2 9398 9099 ("**Promoter**").
3. Entry is only open to Australian residents aged 18 years or over.
4. Employees (and their immediate families) of the Promoter, Royal Randwick Shopping Centre, tenants and their employees of the promoter and agencies associated with this promotion are ineligible to enter.
